Our Policy Work



Andrea Monti (AIIP)

Intermediary liability is a serious matter that should be handled with the utmost care. Since the beginning of the Information Society, European ISPs have not shied away from the legal challenges that have arisen. Over time, they have contributed to the work of the legislators and supported law enforcement in the field, bearing all the costs. Unfortunately, the contribution of the ISPs has often been neglected and, in general, the regulatory approach has been to shift to them the tasks that belong to the public authorities. However, the **Intermediary Liability Committee** will continue to provide experience and expertise to policy makers and legislators to ensure that the rights of the ISP industry are supported in the context of the rule of law and the protection of fundamental rights.



Andreas Gruber (ISPA Austria)

In 2022, the **Cybercrime and Cybersecurity Committee** continued its strong engagement at EU level and beyond. Among other things, the Committee was able to ensure the inclusion of a secure data exchange system in the final text of the E-Evidence Regulation, and that the situation of small providers was sufficiently taken into account in the adoption of the NIS 2 Directive. The year 2023 will be dedicated to the national implementation of these new frameworks, where the Committee will continue to play an active role and assist its members. Besides this, new topics such as the Cyber Resilience Act will move into the focus.



Alex de Joode (AMS-IX)

Children's online protection is a key priority for EuroISPA's **Safer Internet Committee**, and our members have a longstanding relationship with law enforcement authorities to assist them in the fight against CSAM. In the last year, we have met with several EU policymakers working on the proposed CSAM Regulation to provide the technical expertise of our diverse membership on the matter. In 2023, we will continue our engagement efforts, participating in further meetings and events. EuroISPA will have a key role to play in moving away from a polarised debate and instead focusing on the technical implications of the proposed CSAM Regulation.



Asko Metsola (FiCom)

Now that almost all Member States have implemented the DSM Directive, the **Innovation and Growth Committee** can turn its eyes to newer, maybe more national developments. We'll continue to monitor any proposals related to geo-blocking, the territorial dimension of the single market, and different kinds of tax levies. In addition to the Committee's work, I will be attending the EUIPO Observatory Working Groups on EuroISPA's behalf.



Oliver Süme (eco)

Both data protection and the legal challenges around the availability of non-personal data remain a key topic in the process of transitioning Europe into a data economy. In this regard, the analysis of overlap and interdependency of the GDPR, the European Data Act, and the upcoming Artificial Intelligence Act will be of high importance for EuroISPA's **Data Protection Committee**. In addition, the Association will continue to monitor the development of the EU-U.S. Data Privacy Framework and the further legislative process regarding the ePrivacy Regulation.



Michel Combot (FFTélécoms)

In 2022, the **Market and Services Committee** continued its work on 5G & Network Deployment, analysing developments in each national country and identifying barriers and issues that were brought in front of EU lawmakers. Also, the Committee had a strong look at the impact of the Energy crisis on the Internet infrastructure and the services of its members and fostered the exchanges with all stakeholders. The year 2023 will be dedicated to strengthening the activities of the Committee on connectivity issues related to the Internet, in the wake of the initiative of the Gigabit Infrastructure Act proposed by the European Commission.



Malcolm Hutty (LINX)

EuroISPA actively represents the views of the European Internet industry before the most relevant Internet Governance and ICT cooperation organisations such as ICANN, EuroDIG, the Internet Governance Forum and the Council of Europe. Our **International Affairs Committee** brings our members the latest developments and relevant trends at international level, providing a technical forum to discuss the future of our sector.

Intermediary Liability

Over the course of 2022, EuroISPA's Intermediary Liability Committee divided its focus between two main policy issues: the Digital Services Act (DSA) and the Recommendation on piracy of live content. At the beginning of the year, EuroISPA successfully held the last event of its series "DSA in focus" on the upcoming trilogues and the future of content moderation. Besides this, our Association reacted to the plenary vote of the DSA, encouraging policymakers to keep the DSA as a horizontal framework, thus avoiding creating obligations which would result in primary liability for service providers.

EuroISPA also had several meetings with the European Commission on

piracy of live content, voicing the concerns of ISPs on strict removal obligations for intermediaries, which should not set timeframes preventing proper examination of disputed content and noting that providers should be able to choose the technical means to perform web blocking.

In 2023, ahead of the recommendation on piracy of live content scheduled for late April, EuroISPA will participate in further meetings and in a stakeholder hearing with the European Commission and rightsholders, being one of the few ISP representatives that is active on the issue. The Association will also monitor the implementation of the DSA as well as the upcoming delegated acts.

Cybercrime and Cybersecurity

In 2022, EuroISPA actively engaged in the final stages of the negotiations of the E-Evidence Regulation and the NIS 2 Directive. In the first case, EuroISPA pushed to ensure a well-functioning cross-border cooperation between law enforcement authorities and service providers that provides the necessary legal certainty for companies and also takes into account the specificities of SMEs. In addition, EuroISPA has worked towards ensuring that security and confidentiality of data are safeguarded in the transmission of data between service providers and law enforcement authorities which resulted in the development of a new EU wide digital exchange platform. Other aspects that EuroISPA has focused on included reasonable timeframes for emergency situations, a fair system of cost reimbursement, clear provisions for data categories, as well as adequate legal safeguards and coherence among different Member States and third country laws, all while respecting fundamental rights and freedoms.

Concerning the NIS 2 Directive, EuroISPA worked towards a framework that enhances digital security in the EU without creating burdensome requirements for ISPs, particularly when it comes to the proportionality of, for example,

reporting obligations, but also by encouraging the protection of encryption.

In 2023, our Association will focus on the smooth implementation of the aforementioned files, paying particular attention to the development of the digital exchange platform envisaged in the E-Evidence Regulation. Furthermore, EuroISPA will continue using its expert voice in other cybersecurity and cybercrime related initiatives, like the Cyber Resilience Act, and will keep a close eye on developments related to data retention and encryption, especially in the context of the new framework to fight child sexual abuse and, more generally, in the area of cooperation with law enforcement authorities.

Collaborations & Network: Council of Europe

In 2022, EuroISPA continued to build upon its long-standing cooperation with the Council of Europe, with the aim of promoting respect for democracy, human rights, and the rule of law on the Internet.

Safer Internet

In the past year, EuroISPA actively participated in several meetings and events on the CSAM Regulation and it had a key role in moving the discussions away from a polarised debate and focusing on the technical implications. EuroISPA's main priorities on the file remained the respect of encryption in order to guarantee private and safe communications, as well as the prohibition of general monitoring obligations. Besides this, EuroISPA emphasised that blocking orders are not the most suitable and proportionate measure to fight CSAM. Our Association also engaged with EU policymakers to raise awareness on the need to further clarify the role of hotlines.

In 2022, EuroISPA provided input to the European Commission on the Revision of the CSA Directive 2011/93/EU and will continue to closely monitor the developments of the directive in 2023, as well as the Better Internet for Kids Strategy. The association will also engage in and organise events with key EU policymakers and stakeholders on the proposed CSAM Regulation, in order to develop a framework that successfully improves children's safety online and respects the privacy of users.

Collaborations & Network: INHOPE

INHOPE is a global network of 50 member hotlines, leading the fight against child sexual abuse material (CSAM) online since 1999. INHOPE's vision is a world free of CSAM online. They support their member hotlines through training, best practices, quality assurance, and staff welfare. The longstanding and ongoing cooperation between EuroISPA and INHOPE is reflected in a Memorandum of Understanding between the two organisations. This cooperation remains a central feature of the Association's work on hotlines, notably in tackling CSAM. EuroISPA's membership includes several industry-run hotlines, further reinforcing the importance of this partnership, and EuroISPA looks forward to continuing its work with INHOPE in future collaborations.

Innovation and Growth

Over the course of the past year, EuroISPA's Innovation and Growth Committee continued to promote an innovative and open environment for digital content and services. Our Association closely monitored the developments of the European online content legislative framework, including the national implementation of the EU Copyright Directive, offering its members a platform to exchange on best practices, but also to discuss the future of Europe's online content framework.

The new chair of our Innovation and Growth Committee, Asko Metsola, will take on the lead from 2023 onwards, striving to continue EuroISPA's engagement on copyright issues. In this context, EuroISPA and its Internet Services Providers are ready to offer an expert voice in a wide range of areas, including audio-visual and video on demand (VoD), levies and rights management, geo-blocking and content portability, among others, with the aim of supporting the development of an ethical and cross-border online content market in the EU.

Collaborations & Network: European Union Intellectual Property Office (EUIPO)

The EUIPO manages the European trademark and intellectual property policy. EuroISPA is a member of the EUIPO Observatory, an opportunity it uses to convey and emphasise the messages and key issues of the Internet industry with regards to intellectual property practices. The former EuroISPA President, Alexandra Laffitte, was EuroISPA's expert for the EUIPO in 2022. The new chair of our Innovation and Growth Committee, Asko Metsola, will take on the lead from 2023 onwards.

Coalition for Creativity (C4C)

The C4C gathers industry, civil society, consumer groups, and creators who have a shared vision of a modernised copyright regime in Europe. Since its founding in 2012, EuroISPA has played a leading role in the coalition's work and continues to do so, with a particular focus on issues concerning piracy and copyright enforcement.

Data Protection

In 2022, the Data Protection Committee focused its efforts on constructively engaging with policymakers on the proposal for an ePrivacy Regulation, while keeping a close eye on the future frameworks for international transfers of data, and particularly on the EU-US efforts to transition from the Privacy Shield framework. These topics are crucial for EuroISPA's members, especially for European small and medium-sized Enterprises, that would benefit from strong and clear rules around data transfers.

Moving ahead, EuroISPA will continue advocating for a robust legal framework that ensures trust and innovation while safeguarding our network users' privacy and data protection. With that in mind, EuroISPA will continue working with EU and US policymakers and national data protection authorities to secure a new transatlantic agreement that can ensure trust in ever-advancing Internet-based services. Furthermore, our Association will make sure to support negotiators on any steps needed to establish a consistent ePrivacy framework that is workable for our members and aligned with existing EU legislation. We will also keep an eye on developments linked to the enforcement of GDPR, encouraging further harmonisation that will facilitate cooperation and enforcement, also on a cross-border basis.

Finally, EuroISPA will actively engage in the never-ending flow of data protection rules that are crucial for shaping the future architecture of services such as cloud computing and Artificial Intelligence, and do so in a way that promotes innovation within the Internet industry, at all levels.

Collaborations & Network: European Internet Forum (EIF)

The EIF is a platform led by Members of the European Parliament (MEPs) which allows for discussions on digital files between MEPs, industry representatives, and NGOs. It also enables high-level discussions on the political direction of digital legislation and fosters a greater understanding of the impact of technological development. The EIF is an important platform for EuroISPA, offering the opportunity to have fruitful exchanges with stakeholders, gain insight into central digital files, and voice the European Internet industry's concerns and policy suggestions. and copyright enforcement.

Market and Services

During 2022, EuroISPA's Market and Services Committee continued overseeing matters regarding accessibility requirements while following the discussions on the Digital Markets Act. Our members also discussed the consequences for our sector of Russia's aggression against Ukraine, exchanging on best practices when it comes to potential disruptions of the Internet and telecoms infrastructure. They further debated the technical aspects that concern the EU-wide prohibitions for operators to broadcast, enable, facilitate, or contribute to broadcast content by specific entities, to make sure they are aligned with existing case law and fundamental rights.

In 2023, we expect the focus of the Committee to move towards broader connectivity issues, particularly in light of the European Commission's Connectivity package, that includes a proposal for a Gigabit infrastructure act and an exploratory consultation on the future of the connectivity sector

and its infrastructure. EuroISPA will aim to provide its members with a forum to hold an open debate about these topics, including the controversial issue of the compensation for the use of networks.

Collaborations & Network: Internet Corporation for Assigned Names and Numbers (ICANN)

ICANN is a not-for-profit public benefit corporation with participants from all over the world dedicated to keeping the Internet secure, stable and interoperable. It promotes competition and develops policy on the Internet's unique identifiers. Through its coordination role of the Internet's naming system, it has an important impact on the expansion and evolution of the Internet.

Our Association

EuroISPA's activities are led by its members, representing the interests of Internet services providers (ISPs) across Europe. The Board, composed of at least a President, a Vice-President, and a Treasurer, is in charge of the overarching governance and continued functioning of the Association and its Officers are elected every two years by the Council. The Association's activities are supported by the Secretariat, based in Brussels.

Members

Council

EuroISPA is governed by and for its members, through its Council. EuroISPA's Council comprises 10 ISP associations, each appointing a member, representing more than 3,300 ISPs from EU and EFTA Member States.

This body meets four times a year to formally discuss policy issues, matters of importance to the European Internet industry, and the administration of the Association. However, more regular discussions between the members ensure that EuroISPA is a close-knit organisation, taking advantage of the expertise and experience contained therein all-year round.

Council members work in Committees and nominate and elect the Officers.

Hotlines

Several of EuroISPA's national member associations also have hotlines or content-signalling platforms as part of their membership, or even run their own hotlines.

These hotline services play a crucial role in tackling illegal content online, including child sexual abuse material.

Observers

Organisations established in countries which are members of the Council of Europe are also welcome to EuroISPA's membership, as Observers. While these associations do not vote on EuroISPA's decisions, they participate regularly in the Committee Meetings and General Meetings, provide precious input on policy discussions, and have access to all the information the Council and Forum receive. Their perspective is extremely valuable as it broadens EuroISPA's understanding of ICT policy beyond the EU.

Industry Forum

The EuroISPA Industry Forum is a structure which allows individual companies with a legitimate interest in the Internet industry to participate in EuroISPA's activities, discussions, and working groups. The Forum joins Committee meetings to discuss policy issues and provide technical expertise and insight where needed. The Industry Forum acts in a purely advisory capacity to the Council.
